YUKON ENERGY SCHOLARSHIPS GENERAL CATEGORY

- One-year scholarships of \$2,000 for two first year post secondary students
- One-year scholarships of \$2,000 for two students entering second year studies or beyond

Open to Yukon residents studying full-time at a post secondary institution in the areas of electrical or mechanical engineering, electronic systems engineering, civil engineering, and energy related studies.

Yukon Energy is offering four one-year scholarships to Yukon students attending post secondary institutes. Each scholarship is worth \$2,000: two for first year students; another two for students entering second year studies and beyond.

Who may apply?

Canadian citizens, who have lived in the Yukon, for at least one year, and who have been accepted at an accredited post-secondary institution for a diploma or undergraduate degree. Eligible areas of study include electrical or mechanical engineering, electronic systems engineering, civil engineering and energy related studies.

Proof of residency is required.

Students who have previously received a Yukon Energy scholarship are not eligible.

When is the application deadline?

All applications must be received by 4 p.m. on June 30.

How does the selection process work?

A selection committee comprised of Yukon Energy representatives will review applications. Evaluations will be based on the merits of the application and will consider

leadership qualities, balanced lifestyle (i.e. community involvement, extra-curricular activities) and may also consider financial need. Priority will be given to study areas that best relate to the core operations of Yukon Energy.

The selection committee may require an interview with applicants. Failure to participate by phone or in person for an interview may result in scholarship ineligibility.

The proceedings of the selection committee are confidential and its decisions are final.

When are the scholarships awarded?

Scholarships are awarded by late August. You will be informed in writing of the selection committee's decision.

If you are chosen as a recipient, a lump sum payment of \$2,000 will be provided to you in September, once confirmation of your course participation is received.

The Yukon Energy scholarship is classified as income by Revenue Canada and must be declared when filing an income tax return. The program coordinator will provide you with a T-4A slip before the end of February.

What else should you know?

You must begin your studies within six months of being awarded a scholarship. In the event that you withdraw from full-time studies at any point, you must immediately return any unused portion of the scholarship. Students in this situation may re-apply, although the scholarship amount already used will be taken into account when considering your re-application.

You will not be penalized for changing your study area provided it remains within the eligible criteria. You must report other changes outside the eligible study areas to the program coordinator at the earliest opportunity. These changes will generally result in a loss of the scholarship.

You are solely responsible for insuring that your application is complete and contains all necessary documentation. Incomplete or inconsistent applications may be disregarded by the selection committee. Applications and accompanying documentation will not be returned.

You may only receive one Yukon Energy scholarship.

You may be asked to participate in publicity and promotional events sponsored by Yukon Energy.

Students completing high school should provide their most recent report card and a Grade 11 transcript.
